Three highly qualified speakers, Elizabeth Gershoff, Ph.D.. George W. Holden, Ph.D., and Viola Vaughan-Eden, Ph.D., will describe research showing corporal punishment is ineffective and actually teaches violence. Other types of discipline work much better.

Corporal punishment is important in the family/divorce court crisis because it is legal to some degree in all 50 states. That makes it hard to draw the line, and to ensure supervised visits of children with batterers.

The irony is that in 31 states, corporal punishment is banned in schools. Schools in 19 states can still, and do, hit children with wooden paddles, which TSA considers a weapon and cannot be brought on to a plane in carryon luggage. African American children are far more likely to be hurt in school paddling. This brings up the specter of a shameful time in our history when slaves (and women) could be beaten with impunity.

We are delighted Congress is moving forward on child safety issues!

- Representative Sheila Jackson Lee (TX) is sponsoring a Concurrent House Resolution to make child safety is the first priority of custody and visitation adjudications (the language has not come out yet)
